In this environment of high costs for fuel, fertiliser, labour, transport, one doesn't have to be a bad farmer or business person to get in to trouble and Rural Business Tasmania is ready to assist as required.

I would like to say well done to our team, providing service to all areas of Tasmania. The team has continued to grow and diversify to meet the needs of new programs. Well done to the Executive, especially CEO Elizabeth Skirving for the achievements of the past 12 months. Thank you also to our funding bodies, partners and colleagues within the industry who have worked collaboratively with us to support our great rural and regional communities. Finally, I would like to thank Board Members for their significant contributions.





Chairman - Rural Business Tasmania

Chief Executive Officer's Report

Rural Business Tasmania continues to grow in strength and reputation to be positioned as a key service provider in Tasmania's rural and regional communities.

Our vision focussed on supporting those running a small business and needing support with or wishing to expand their skills in business and financial management.

During July 2021 to June 2022 our industry faced a variety of opportunities and challenges as the world continued to navigate the pandemic. Rural Business Tasmania play a critical role in supporting our clients and community in adapting to change, encouraging resilience, and providing a vehicle for collaboration and effective service provision.

The agricultural community's return to prosperous seasons continued with good climatic conditions, good commodity prices and limited impact from the pandemic. Our small businesses endured further impacts of COVID-19 and our additional service portfolio has provided valuable support. Key issues that the business industry has experienced include workforce challenges, freight and supply logistics, increased costs and changing supply demands.

Significant uncertainty of funding options for our Rural Financial Counselling program post June 2021 due to funding renewal delays were resolved when in late April we secured a three-year funding grant for the Rural Financial Counselling Service (RFCS) with funds received from Australian and Tasmanian Governments. This allowed our financial counselling suite of services, RFCS Tasmania and Small Business Support Program to continue with

ongoing support to all rural and regional small business, including farming, fishing, and forestry.

We have also had additional program support for our proactive programs from the Tasmanian Government and enjoy a close working relationship with Agri Growth. We have continued to provide ongoing programs including:

- >> Forestry Contractors Resilience Program
- >> Cultivating Rural Excellence Program
- >> Agribusiness Career Pathways (ACP)
- >> Cadetship Program
- >> Mentorship Program

We have been successful in obtaining new funding (Australian and Tasmanian Government sources) for a number of programs and will be announcing commencements during coming months. These programs include:

- >> eNABLE learning and extension skills development program (in partnership with Tasmanian Institute of Agriculture (TIA)
- >> Drought Risk Assessment Toolkit Project (in partnership with Derwent Valley Catchment Group)
- >> 26TEN Adult Numeracy and Literacy Program
- >> Building resilience workshops

We thank the Australian and Tasmanian Governments and each of the funding streams for their continued backing.

The Rural Relief Fund, through the provision of

emergency grants, provided support to a number of business families to build resilience or to meet immediate hardship requirements of household or animal welfare. We continue to hold funds from Tasmanian Government, corporate and individual sponsors but will be looking to further build on this to meet future demands for assistance.

The Forum of Rural Stakeholders, convened by Rural Business Tasmania and chaired by Rural Business Tasmania's Chief Executive, has again grown in membership and profile. Rural Business Tasmania has also continued to participate in industry discussions during this time and be available and ready to assist where appropriate. We have strong networks and stakeholder relationships and actively seek opportunities to work together.

The Australian Government, supported by Tasmanian Government, continued to expand, and develop a suite of programs and concepts to assist with adaptation, innovation and resilience to drought through the Future Drought Fund. Rural Business Tasmania were involved in discussion from early concept and have become a partner in the Adoption and Innovation Hub for Drought Resilience - Tasmania. We continue to look for opportunities to support our business clients to build a resilient, adaptive enterprise through managing the ever-present challenges and building risk mitigation strategies.

I would like to thank our Chairman, Michal Frydrych, and Board members for the support of myself and our team throughout the year. We have new Board Members and established a revised strategic plan that we will commence actioning in the coming 12 months.

Our operational team continues to evolve as new programs and opportunities arise. Our team have provided professional service to each participant of our programs through direct service delivery or supportive administration. Each has passion for the work we do and take pride in the communities that we support.

We thank all involved – Board, staff, funding bodies, industry, and key partners.



Rural Financial Counselling Service

Rural Financial Counselling Service (RFCS) remains the flagship program for the organisation — a highly respected and valued service that has been operational for over 30 years. We strive to achieve best practice providing support to Tasmanian rural and regional agribusiness and look for opportunities for enhancement.

Rural Business Tasmania in early 2021 was successful in securing the Australian Government's competitive tender process to deliver the new Rural Financial Counselling (RFCS) Program for Tasmania.

This new program is focussed on resilience and recovery.

During the 2021-2022 year, Rural Business Tasmania employed Rural Financial Counsellors based in the following locations:

- >> North West
- >> North/North East
- >> Southern

A brief summary of factors for 2021-2022 impacting on primary production and ultimately the demand for the RFCS include:

- >> Commodity prices across the beef, sheep & dairy sectors remain high which has increased demand for financial counselling services
- >> North West Tasmania has experienced drier than normal conditions at times, however the remainder of the State has seen rainfall at or slightly above long-term averages. Portions of the East Coast and Southern Midland regions are still in recovery mode from the many years of drought like conditions.
- >> COVID-19 related challenges continued to impact in aspects such as access to goods & labour e.g. harvest workers.
- The Tasmanian Seafood Industry continued to suffer significant financial hardship as a whole due to loss of markets from COVID-19 and international trade issues which resulted in an increase in demand for our services. Rural Business Tasmania is working with the Tasmanian Seafood Industry Council (TSIC) to support this sector.

Client Levels


Client numbers have reduced from a peak of 165 clients to 127 clients as at the 30th June 2022.


This is primarily due to record commodity prices in the beef, sheep and dairy sectors.


Primary producers in the Midlands & East Coast regions are seeking our assistance as they continue to recover from the extended dry conditions that have prevailed for several years.

The majority of our new clients were referred from a government agency (e.g. Services Australia, Dept. Agriculture Fisheries & Forestry, etc.) or through word of mouth however discovery of RFCS via social media is increasing.


Farm Debt Mediation

Counsellor Engagement

Clients in general are now assessed in one of two ways:

1. TRANSACTIONAL

Can be either complex or non-complex e.g. assist client with a loan application (complex) or assist with grant application (non-complex).

2. CASE MANAGED CLIENT

Holistic approach taken and client assisted in becoming financially resilient and self-sufficient through coaching and empowerment. Client is assisted with either succeeding, succession or exiting as required.


The bulk (over 95%) of our clients are considered as case managed clients

Community Engagement and Referrals to External Partners in Times of Need

Our Financial Counsellors have worked alongside many varying industry partners and provided immediate on the ground assistance when natural disasters have impacted such as the Huonville bushfire event in early 2022.

The Rural Financial Counselling team has also partnered with Services Australia and the National Resilience and Recovery Agency for various roadshows and presentations across multiple towns throughout regional support groups/organisations such as Rural Alive & and rural Tasmania.

Our counsellors continue to regularly refer their clients to external parties in order to ensure that they are accessing all the necessary support and assistance they require in helping build their financial resilience.

A strong focus is to assist clients in accessing support around mental and emotional well-being. Our counsellors regularly refer clients to various social Well or our new program aimed at increasing adult literacy and numeracy skills – 26TEN and or their medical



Small Business Support Program

Rural Business Tasmania's Regional Small Business Support Program is designed to assist regional and rural small business enterprises that are either under financial hardship or have the potential to be under financial hardship.

The focus of the program is to assist businesses to:

- >>> Better understand their financial position and options moving forward
- >> Develop self-reliance and enhance business viability
- >>> Access assistance measures as required

This program has been in operation since February 2020 with funding provided by a mixture of Federal and State Government assistance.

This program whilst being able to provide support to any small business across the State, has chosen to focus its emphasis on business's located greater than 20 kilometres from Hobart or Launceston, noting businesses within this 20km radius are still eligible for support.

Client Focused Outcomes

The program key areas of focus and client assistance include:

- >> Understanding their current financial position
- >> Identifying options and implement plans to improve the viability of their enterprise
- >> Understanding the benefits and drawbacks of different options to manage financial issues
- >> Develop budgets and cash flow management
- >> Negotiate with creditors and financial providers on behalf of the client
- >> Understand rights and access broader professional advice and support services
- >> Access government and community grants, programs or schemes




The program has been accessed by small business across all regions of Tasmania, with the exception of the Bass Strait Islands.

Coupled with the above charts the strongest demand by location has been Southern Tasmania with the Glamorgan Spring Bay, Sorell and Tasman Peninsula Local Government Authorities seeing highest demand.

North West

Profile of a Typical Client Assisted

A typical regional small business program support client resides in a regional town of less than 5,000 people situated on the south east coast of Tasmania.

The business will provide food and or accommodation services and has 2.5 employees including the owner.

The business has typically been in operation for 6.5 years with an average turnover in the preceding 12 months of \$178,000

The client would have presented seeking assistance due to the business either not covering expenses or covering expenses but not making a profit.

The business will not have a business plan or cash flow budget.

It should be noted that only 20% of businesses assisted to date, actually have had a business plan prior to seeking our help.

Assistance will be typically sought for:

- >> Diversifying the business (products/services, customer base)
- >> Forecasting cash flow and managing day-to-day finances
- >>> Promotion/marketing e.g., establish a digital presence (Website, Facebook etc)


Assistance Provided

Strongest demand has been seen in the accommodation and retail sectors with COVID-19 related impacts being the main cause for businesses seeking assistance.


Coupled with the above, strongest demand by location has been in the Circular Head LGA and the Glamorgan Spring Bay LGA.

Uncertainty around funding post June 2021 led to a reduction in client numbers in April and May 2021. In late May 2021 funding was recommitted to the program and client numbers increased.

Rural Business Programs

Our Rural Business Programs team has seen significant growth over the past twelve months. New and existing programs being undertaken include:

- >>> Forestry Contractors Resilience Program
- >> Cultivating Rural Excellence Program (CRE)
- >> 26TEN Adult Numeracy & Literacy Program
- >> eNABLE Learning & Extension skills development program in partnership with the Tasmanian Institute of Agriculture (TIA)
- >> Drought Risk Assessment Toolkit Project in partnership with the Derwent Valley Landcare
- >>> Cadetship Program
- >> Mentorship Program

Our business programs are designed to support and develop both the skillset and knowledge base of Tasmanian regional and rural communities and primary producers alike through innovative programs.

Our programs are funded through a mixture of Australian and Tasmanian Government funding, commercial support from regional and rural Tasmanian businesses and program participants.

Forestry Contractors Resilience Program

The Forestry Contractors Resilience Program was funded by the Tasmanian Government and has been successfully delivered.

This program allowed Tasmanian forestry harvest and haulage contractors to have the opportunity to work with specialists in business and financial management to identify future opportunities and build stability and resilience into their operations.

Eligible applicants received up to 5 hours of professional business coaching and up to \$15,000 to deliver agreed business improvements. The project funded safety upgrades to machinery, training of staff, upgrades to compliance software and purchase of new equipment to diversify income streams.

Key Outcomes Delivered:



27 grants paid out



\$386,350 total value of grants paid out to contractors



127 hours of business coaching delivered

Rural Business Programs

26TEN Adult Numeracy, Literacy & Digital Literacy Skills Development Program

Approved in May 2022 and funded by the Tasmanian Government, the 26TEN pilot program is designed to provide in-home support in the areas of literacy, numeracy and digital literacy in rural and regional communities.

The pilot will initially operate in Northern Tasmania with the potential to expand should demand warrant.

Participants can access up to 15 hours of one-on-one in home support to be conducted by an Adult Literacy Skills Officer.

As part of the program, Rural Business Tasmania staff have been provided training in how to identify and refer clients with potential literacy and numeracy issues.

Rural Business Tasmania is acting as a referral service to the 26TEN program, and has also engaged key stakeholders such as Tasmanian Fire Service, major banks and industry bodies to broaden the potential reach of the program.

eNABLE – Nurturing Agri Business Learning and Extension

This is a joint project between Rural Business Tasmania, The Tasmanian Institute of Agriculture (TIA) and the Australian Government Community Grants - Ag Up Program.

The project aims to develop and roll out a new training program targeting three distinct groups of people:

- 1. Owners and managers of small to medium agricultural and rural businesses
- 2. Early-career extension officers and consultants
- 3. Mid-career extension officers or consultants seeking to develop/refresh skills

Training will be delivered by fully qualified and registered training organisations via a mixture of face to face training and on-line sessions. Between 30 and 40 participants are expected to be trained each year.

The training developed will be a combination and merger of two independent training programs previously delivered (Cultivating Rural Excellence via Rural Business Tasmania and TIA's Extension Accelerator Program).

Drought Risk Assessment Toolkit (DRA)

Our Tas Ag Innovation Hub application for the Drought Risk Assessment – Practical Management Support to Build Resilience was lodged in April 2022 and approved in July 2022.

The total project funding will allow Rural Business Tasmania in partnership with the Derwent Catchment Project to deliver a Drought Risk Self-Assessment toolkit. This toolkit is designed to help farming operators gauge current susceptibility and preparedness in relation to drought conditions, covering topics such as access to water, land management, forecasting and trigger points as well as enterprise flexibility and financial resilience.

The assessment tool kit will then provide practical management steps to make improvements in these areas.

Rural Business Programs

Building Resilience Workshops

Our Building Resilience Workshops, funded by the National Emergency Management Agency (NEMA) are designed to support disaster prone Local Government Areas (LGAs) to better understand emergency response and preparedness.

These workshops will include key speakers from the SES, Tasmanian Fire Service, involved councils and Rural Business Tasmania.

Three key LGAs identified to host these workshops for the first round are:

1. Huon 2. Tasman 3. Break O'Day

These locations are subject to change for future rounds, pending disaster events in the upcoming seasons.

Cadetship Program

The Cadetship Program is designed to bring young people and employers together to create opportunities in rural communities and attract young people into agriculture.

A review of this program was conducted in late 2021 with a new project plan developed in conjunction with Skills Tasmania. This program is funded by the Tasmanian Government and supported by various industry stakeholders.

The aim of the program is to give year 11 and 12 students the opportunity to be placed in work experience roles in the agricultural sector with the intention of leading to a traineeship or apprenticeship.

Mentorship Program

Treasurer's Report

An overview of financial activities and the audited financial statements for the 2021-2022 financial year shows that income has remained steady at \$1.7m which has resulted in a sound operating surplus of \$77,000.

It is important to acknowledge that whilst we are a not for profit organisation, a sound surplus enables Rural Business Tasmania to deliver programs as well as the ability to evolve with the needs of our rural and regional communities.

Financial Reporting

To ensure financial governance remains at the highest level, financial reporting has been provided to the Board on a monthly basis. Reports include Profit & Loss Statement, Balance Sheet and Operating Statement including a detailed overview of the financial situation.

The Board of Rural Business Tasmania established a Finance Committee in June this year. The primary purpose of the Finance Committee is to assist the Board with monitoring and overseeing the company's balance sheet, and provide recommendations on Rural Business Tasmania capital management strategy.

The Finance Committee comprises of the Treasurer and at least one or more other Board members. Findings and recommendations are reported to the Board after each meeting.

Audit of Accounts and Compliance

The audit report for the 2021-2022 year has been completed utilising the general purpose financial statements methodology as issued by the Australian Accounting Standards Board.




